In pursuance of instructions received from Government of India, Ministry of Rural Development, New Delhi vide Letter No. K-15017/07/2013-Trg., dt.18.6.2013 (Ref-1), a proposal on modification in the constitution of Executive Council of NIRD by amending the Rule X (i) of Rules of NIRD, 1991 was placed before the General Council of the Institute in its 60<sup>th</sup> meeting held on **11.07.2013**.

2. Accordingly, the General Council approved the proposed amendment of **Rule X (i) of Rules of NIRD, 1991** on constitution of Executive Council. Government of India, Ministry of Rural Development vide its letter No. K-15017/10/2013-Trg, dt.29.8.2013 (Ref-2) conveyed the approval of the Hon'ble Minister of Rural Development and President, General Council to the minutes on recommendations of General Council.

3. The details of proposed amendment in Rule X (i) of Rules of NIRD, 1991 as approved by the General Council are as follows :

i. **Existing composition of the Executive Council as provided under Rule X (i) of the Rules of NIRD, 1991 -**

(a) Union Minister of Rural Development who is also the President of the General Council shall be the Chairman of the Executive Council.  
(Revised vide Office Order No. 578, dt.16<sup>th</sup> October, 2003 ).

(b) The Director General of the Institute.

- (c) Secretary (RD), Secretary (DWS), Joint Secretary as well as Financial Adviser in the Ministry/ Department of Rural Development, Government of India dealing with the Institute.
- (d) Five eminent persons who have made note-worthy contributions in the fields of Rural Development, reconstructions and allied subjects, to be nominated by the President of the Institute from among the members of the General Council.
- (e) Two members to be nominated by the President of the Institute from among the non-official members of the General Council.
- (f) Secretary, Department of Personnel and Training, Government of India, New Delhi or his nominee not below the rank of Joint Secretary to Government of India.

- (g) Secretary, Ministry of Panchayati Raj, Government of India  
(Revised vide Office Order No.569, dt.21.11.2011 read with corrigendum dt.31.1.2012 as approved by the General Council in its 59<sup>th</sup> meeting held on 11.06.2011)

ii. **Proposed composition of the Executive Council after amendment of Rule X (i) of Rules of NIRD, 1991 -**

- (a) Secretary,  
Ministry of Rural Development, Govt. of India - Chairperson
- (b) Secretary,  
Ministry of Panchayati Raj, Govt. of India  
(or a nominee not below the level of  
Additional Secretary) - Member
- (c) Secretary,  
Department of Land Resources  
(or a nominee not below the level of  
Additional Secretary) - Member
- (d) Secretary,  
Ministry of Drinking Water and Sanitation  
(or a nominee not below the level of Joint Secretary) - Member
- (e) Five eminent persons from the field of Rural Development nominated by the President of the Institute from among the members of the General Council.

- (f) *Two non-official members nominated by the President of the Institute from among the members of the General Council.*
- (g) *Joint Secretary, Department of Personnel and Training dealing with training.*
- (h) *Additional Secretary, Ministry of Rural Development*
- (i) *Financial Adviser, Ministry of Rural Development*
- (j) *Director General, NIRD (Member Secretary)*
